A Resolution recommending Award of the Contract under PR No. 22-08-788 and Bid Reference No. 2022-43 entitled "One (1) Year Comprehensive Maintenance Service of a Back-Up Power Supply of BFAR Main Data Center" to Multi-fold Links, Inc. for being the Single Calculated and Responsive Bidder.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot and with an Approved Budget for the Contract (ABC) amounting to Three Million Eight Hundred Thousand pesos (\$\mathbb{P}\$ 3,800,000.00) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 8983695 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

whereas, eight (8) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: (1) MJZ Integrated Industrial Co, (2) Action Labs IT Services Phils. Corp., (3) Integrated Computer Systems, Inc., (4) EGM Systems Global technologies Inc., (5) Automation Specialists and Power Exponents, Inc., (6) LSI Leading Technologies Inc., (7) Comfac Corporation and, (8) Powercraft Solutions and Data Infrastructure Inc.;

WHEREAS, on 17 August 2022, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

whereas, on 13 September 2022, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein (1) Multi-fold Links, Inc. and (2) Mekanismo Incorporated participated.

whereas, on 30 September 2022, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only Multifold Links, Inc. participated;

- WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the bidder/supplier were "PASSED" and declared eligible for the opening of the financial bid envelope;
- WHEREAS, the financial bid envelope submitted was opened and Multi-fold Links, Inc. bid offer is Three Million Seven Hundred Eighty-Seven Thousand Eighteen pesos (#3,787,018.00) only:
- WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared Multi-fold Links, Inc. offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;
- WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last 11 October 2022, it was proposed that Multi-fold Links, Inc. be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post Qualification procedure;
- whereas, on 18 October 2022, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to Multi-fold Links, Inc., being the Single Calculated Responsive Bidder;
- WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to Multi-fold Links, Inc.;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2022-43 entitled "One (1) Year Comprehensive Maintenance Service of a Back-Up Power Supply of BFAR Main Data Center", be awarded to Multi-fold Links, Inc. in the amount of Three Million Seven Hundred Eighty-Seven Thousand Eighteen pesos (\$\mathbb{P}\$ 3,787,018.00) for being the bidder who offered the Single Calculated and Responsive Bid;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidders, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
