**CONTRACT AGREEMENT FOR GOODS & SERVICES**

THIS AGREEMENT made on this \_\_\_ day of \_\_\_ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **MULTI-FOLD LINKS, INC.** of *Platinum 2000, Annapolis Street, Greenhills, San Juan City, Metro Manila* (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference No. 2022-43** entitled "**ONE (1) YEAR COMPREHENSIVE MAINTENANCE SERVICE OF A BACK-UP POWER SUPPLY OF BFAR MAIN DATA CENTER**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE MILLION SEVEN HUNDRED EIGHTY-SEVEN THOUSAND EIGHTEEN PESOS (₱ 3,787,018.00)** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


