CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the ___ day NOV 15 2022 2022 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **MULTI - FOLD LINKS, INC.** of Platinum 2000, Annapolis Street, Greenhills, San Juan, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for Lot No. 1 and 2 with **BID REFERENCE NO. 2022 - 44** entitled "**RENEWAL OF INTEGRATED I.T. MANAGEMENT AND ENDPOINT PROTECTION PLATFORM LICENSES OF BFAR - CENTRAL OFFICE**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE MILLION FIVE HUNDRED NINETY - SIX THOUSAND PESOS ONLY (PhP 9,596,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of **NINE MILLION FIVE HUNDRED NINETY - SIX THOUSAND PESOS ONLY (PhP 9,596,000.00)** or such other sums as may be ascertained, **MULTI - FOLD LINKS, INC.** agrees to **BID REFERENCE NO. 2022 - 44** entitled "**RENEWAL OF INTEGRATED I.T. MANAGEMENT AND ENDPOINT PROTECTION PLATFORM LICENSES OF BFAR - CENTRAL OFFICE**" in accordance with his/her/its Bid.
 4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
