CONTRACT AGREEMENT FOR INFRASTRUCTURE PROJECTS

THIS AGREEMENT made this ___ day of 4 NOV 2022 2022 between **DEPARTMENT OF AGRICULTURE - BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA - BFAR)** of Fisheries Building Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City, Philippines 1101 (hereinafter called "the Entity") and **ZANEYA BUILDERS & SUPPLY** of 26 Dominga Village Mendez Street, Brgy. Baesa, Quezon City (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "**CONSTRUCTION OF SEAWATER INTAKE HOUSE, SEAWATER PIPELINES, SUPPLY AND INSTALLATION OF TWO (2) UNITS SEAWATER PUMP MACHINES**" with **BID REFERENCE NO. 2022 - 47** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION SEVEN HUNDRED NINETEEN THOUSAND SEVENTY-EIGHT PESOS (₱ 2,719,078.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of **TWO MILLION SEVEN HUNDRED NINETEEN THOUSAND SEVENTY-EIGHT PESOS (₱ 2,719,078.00)** or such other sums as may be ascertained, **ZANEYA BUILDERS & SUPPLY** agrees to **BID REFERENCE NO. 2022 - 47** entitled " **CONSTRUCTION OF SEAWATER INTAKE HOUSE, SEAWATER PIPELINES, SUPPLY AND INSTALLATION OF TWO (2) UNITS SEAWATER PUMP MACHINES**" in accordance with his/her/its Bid.


4. The **DA - BFAR** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
