CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the ___ day of **NOV 02 2022** 2022 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **CHILL - PERSHA ENTERPRISE** of MC Arthur Highway Caniogan, Calumpit, Bulacan, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **Lot No. 3** with **BID REFERENCE NO. 2022 - 51** entitled "**SUPPLY AND DELIVERY OF UNDERWATER FITTINGS FOR THE CONSTRUCTION OF 610 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIVE MILLION NINE HUNDRED TWELVE THOUSAND ONE HUNDRED TWENTY PESOS ONLY (PhP5,912,120.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;




