- 2. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI Schedule of Requirements. Bidders should have completed, within **five (5)** years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- **4.** Prospective Bidders may obtain further information from BFAR BAC Secretariat through electronic mailing address given below, and inspect of the Bidding Documents at www.bfar.da.gov.ph.
- A complete set of Bidding Documents may be acquired by interested Bidders on November 23, 2022, to December 13, 2022, from 8:00 AM to 5:00 PM, at the given address and website/s below upon payment of a non-refundable fee for the Bidding Documents in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.

- **8.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on <u>December 13, 2022 (Tuesday), at 01:30 PM</u> through video conferencing or webcasting via "Zoom" application. Bids will be opened in accordance with the BFAR BAC procedure for online bidding as stated in the "Annex A, Bidder's kit VII".
- **10.** The DA BFAR, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
