The Department of Agriculture (DA) Bureau of Fisheries and Aquatic Resources (BFAR) through the General Appropriations Act for 2023 intends to apply the sum of **TWENTY-EIGHT MILLION TWO HUNDRED FORTY-FIVE THOUSAND EIGHTY-ONE PESOS (₽ 28, 245, 081.00)** being the ABC to payments under the contract for **Bid Reference No. 2022-60** entitled "SUPPLY OF MATERIALS AND LABOR FOR DRY DOCKING AND REPAIR OF DA-BFAR MCS 3009 PATROL VESSEL".
- 2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 3. The DA-BFAR now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in Section VI Schedule of Requirements. Bidders should have completed, within *five (5) years from the date of submission and receipt of bids*, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures via electronic or online means using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 and in accordance with the procedural guidelines under BAC Resolution No. 2020-55, attached hereto as Annex A "Adoption of

Guidelines for the Electronic Submission of Bids in accordance with GPPB Resolution 09-2020".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5. Prospective Bidders may obtain further information from the BFAR BAC Secretariat through the electronic mailing address given below, and inspect the Bidding Documents at <u>www.bfar.da.gov.ph</u>.
