A Resolution recommending Award of the Contract under PR No. 22-08-870 and Bid Reference No. 2022-47 entitled "CONSTRUCTION OF SEAWATER INTAKE HOUSE, SEAWATER PIPELINES, SUPPLY AND INSTALLATION OF TWO (2) UNITS SEAWATER PUMP MACHINES" to Zaneya Builders & Supply for being the Single Calculated and Responsive Bidder.

WHEREAS, on 07 September 2022, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot and with an Approved Budget for the Contract (ABC) amounting to Two Million Seven Hundred Twenty-Nine Thousand Seventy-Eight pesos (₱ 2,729,078.00) and posted at the websites of the Philippine Government Electronic Procurement Service (PhilGEPS) with Reference No. 9063525 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: (1) G.R. Ercilla Construction and, (2) OEM Industrial Parts and Construction Services Corporation;

WHEREAS, on 06 October 2022, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein three (3) bidders participated namely, (1) **Zaneya Builders**, (2) **Mannymeld's Construction and Iron Works** and, (3) **Ahyok Construction Supply**.

WHEREAS, on 18 October 2022, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only **Zaneya Builders & Supply** participated;

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the bidder/supplier were "PASSED" and declared eligible for the opening of the financial bid envelope;

WHEREAS, the financial bid envelope submitted was opened and **Zaneya Builders & Supply's** bid offer is **Two Million Seven Hundred Nineteen Thousand Seventy-Eight pesos only (₱ 2,719,078.00);**

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **Zaneya Builders & Supply** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last *28 October 2022*, it was proposed that **Zaneya Builders & Supply** be declared as the ***Single Calculated and Responsive Bidder*** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, on *07 November 2022*, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **Zaneya Builders & Supply**, being the ***Single Calculated Responsive Bidder***;

WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **Zaneya Builders & Supply**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. 2022-47** entitled "**CONSTRUCTION OF SEAWATER INTAKE HOUSE, SEAWATER PIPELINES, SUPPLY AND INSTALLATION OF TWO (2) UNITS SEAWATER PUMP MACHINES**", be awarded to **ZANEYA BUILDERS & SUPPLY** in the amount of **Two Million Seven Hundred Nineteen Thousand Seventy-Eight pesos only (₱ 2,719,078.00)** for being the bidder who offered the ***Single Calculated and Responsive Bid***;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
