A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-48 "SUPPLY AND DELIVERY OF BUSINESS GRADE COMPUTER WORKSTATION AND LAPTOP" TO JONECO TECH. MARKETING CORP. FOR BEING THE SINGLE RESPONSIVE CALCULATED BIDDER.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the procurement project **UNDER BID REFERENCE NO. 2022-48** entitled **"SUPPLY AND DELIVERY OF BUSINESS GRADE COMPUTER WORKSTATION AND LAPTOP"** (herein referred to as "Procurement Project") consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference no. 8760580, in the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on 19 September 2022 at 11:00 am the Pre-Bid Conference for the Procurement Project was held at the BFAR BAC Office, 2nd Floor Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City and *via ZOOM Meeting Application*;

WHEREAS, on 22 September 2022, a Supplemental Bid Bulletin No. 1 was issued and posted in the Philippine Government Electronic Procurement Service (PhilGEPS), in the Bureau's website (www.bfar.da.gov.ph), in conspicuous places within the Bureau's premises;

WHEREAS, on 30 September 2022, 11:00 am, the opening of bids for the Procurement Project was held at the BFAR BAC Office, 2nd Floor Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City and *via ZOOM Meeting Application*;

WHEREAS, in the said Bid Opening, only **JONECO TECH. MARKETING CORP.** submitted their bid envelopes;

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by **JONECO TECH. MARKETING CORP.** they are declared **"PASSED"** and eligible for the opening of the financial bid envelopes;

WHEREAS, during the opening of the financial bid envelope submitted by **JONECO TECH. MARKETING CORP.** its bids is read and tabulated as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/s, the BAC declared the offer of **JONECO TECH. MARKETING CORP.** as the single bid as read for the said procurement project will be subjected to detailed bid evaluation and post qualification process to be conducted by the TWG;

WHEREAS, the BAC ordered that the copies of the Eligibility, Technical and Financial envelopes of the bidder be forwarded to the TWG for detailed bid evaluation and post-qualification process;

WHEREAS, the Technical Working Group (TWG) submitted the bid evaluation report stating *inter alia* their recommendation for the conduct of the post-qualification process on the offer of **JONECO TECH. MARKETING CORP.;**

WHEREAS, the post qualification documents submitted by the **JONECO TECH. MARKETING CORP.** as SINGLE RESPONSIVE calculated bidder was transmitted to the TWG;

WHEREAS, the TWG recommending the post qualification report that the award for the Procurement Project be given to **JONECO TECH. MARKETING CORP.** as *SINGLE Calculated and Responsive Bidder with the Technical Specification;*

WHEREAS, the BAC, after due consideration on the report of the TWG, resolved to adopt the same and recommend the awarding of contract to **JONECO TECH. MARKETING CORP.;**

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2022-48 entitled **"SUPPLY AND DELIVERY OF BUSINESS GRADE COMPUTER WORKSTATION AND LAPTOP"** to **JONECO TECH. MARKETING CORP.** for being the Single Calculated and Responsive Bid in the total amount **SEVEN MILLION NINE HUNDRED FIVE THOUSAND AND FOUR HUNDRED PESOS ONLY (PhP 7,905,400.00).**

RESOLVED FINALLY that the Notice of Award be issued to **JONECO TECH. MARKETING CORP.** for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods.
