4. When it comes to SSS, what will be the basis for computation, the basic salary or the rulings of SSS the basis for computing SSS are the remuneration except 13 th month pay?	4. The Bureau responded the bidder/s should follow the SSS rulings.
5. What are we going to follow with the agency fee? The not less than 20% of DOLE? GPPB, no flooring, no ceiling?	5. The Bureau responded that the DOLE 18-A should be applied for the implementation of janitorial services.


All other portions of the Bidding Documents affected by these amendments shall be made to conform the same.
