RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-59, ENTITLED "HIRING OF DA-BFAR SECURITY SERVICES FOR THE PERIOD OF JANUARY 2023 TO DECEMBER 31, 2023" TO STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. 22-11-1218 pertains to the Hiring of Security Services for the Period of January- December 31, 2023 for the Bureau of Fisheries and Aquatic Resources (BFAR) with an Approved Budget for the Contract amounting to Php 34,000,000.00;

whereas, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9263827, the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** on December 01, 2022 (Thursday) at 01:30 pm, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by the following bidders:

- North Pacific Security Agency, Inc.

WHEREAS, the opening of bids was conducted last December 13, 2022, 01:30 pm via Zoom and was only participated by Star Special Corporate Security Management, Inc.;

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes the abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

whereas, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC. for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project entitled "HIRING OF DA-BFAR SECURITY SERVICES FOR THE PERIOD OF JANUARY TO DECEMBER 31, 2023" is recommended to be awarded to STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC. for being the Single Calculated & Responsive Bid in the amount of THIRTY-THREE MILLION EIGHT HUNDRED SIXTY THOUSAND FIVE HUNDRED EIGHTY-TWO AND 88/100 PESOS (Php 33,860,582.88) ONLY.
