A Resolution recommending Award of the Contract under PR No. 22-11-1219 and Bid Reference No. 2022-60 entitled "SUPPLY OF MATERIALS AND DRY DOCKING AND REPAIR OF DA-BFAR MCS 3009 PATROL VESSEL" to JOSEFA SLIPWAYS, INC. for being the Single Calculated and Responsive Bidder.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *single* lot and with an Approved Budget for the Contract (ABC) amounting to Twenty Eight Million Two Hundred Forty-five Thousand Eighty One pesos (₱ 28,245,081.00) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 9249321 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for *seven (7)* days;

WHEREAS, seven (7) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: (1) Inca Philippines, Inc., (2) Buenafer Marine Spare Parts and Services (3) Golden Arrow Trading, (4) Propmech Corporation, (5) Josefa Slipways, Inc., (6) Sas Shipyard, Inc., and (7) All Certified Equipment Trading Corporation;

WHEREAS, on *17 November 2022*, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, on *25 November 2022*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder participated namely, **Josefa Slipways, Inc.;**

WHEREAS, on *07 December 2022*, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder submitted its bid envelopes namely **Josefa Slipways, Inc.;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by the bidder/supplier were “PASSED” and declared eligible for the opening of the financial bid envelope;

WHEREAS, the financial bid envelope submitted was opened and **Josefa Slipways, Inc.** bid offer (Lot 1) is **Twenty-eight Million One Hundred Thirty-seven Thousand Seventy-three pesos and Forty-nine centavos (₱ 28,137,073.49)** only:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **Josefa Slipways, Inc.** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last *14 December 2022*, it was proposed that **Josefa Slipways, Inc.** be declared as the ***Single Calculated and Responsive Bidder*** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, on *05 January 2023*, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **Josefa Slipways, Inc.,** being the ***Single Calculated Responsive Bidder;***

WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **Josefa Slipways, Inc.;**

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. 2022-60** entitled “**SUPPLY OF MATERIALS AND DRY DOCKING AND REPAIR OF DA-BFAR MCS 3009 PATROL VESSEL**” be awarded to **Josefa Slipways, Inc.** in the amount of **Twenty-eight Million One Hundred Thirty-seven Thousand Seventy-three pesos and Forty-nine centavos (₱ 28,137,073.49)** for being the bidder who offered the ***Single Calculated and Responsive Bid;***

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidders, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
