RESOLUTION NO.:PB 2022-63

A Resolution recommending Award of the Contract under PR Nos. 22-11-1227, and 22-12-1283 and Bid Reference No. 2022-63 entitled "SUPPLY AND DELIVERY OF POST-HARVEST EQUIPMENT FOR DISTRIBUTION TO REGIONS 5,6,7,8 & 9" to Double J Agri Supply for being the Lowest Calculated and Responsive Bidder.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *three (3)* lots and with an Approved Budget for the Contract (ABC) amounting to Six Million Sixty-nine Thousand Nine Hundred Seventy-five Pesos (₱ 6,069,975.00) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 9331783 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for *seven (7)* days;

WHEREAS, seven (7) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely:

- (1) Buenafer Marine Spare Parts and Services;
- (2) All Certified Equipment Trading Corporation;
- (3) Inca Philippines, Inc.;
- (4) Remaru Industrial Design and Fabrication;
- (5) Verika General Merchandise;
- (6) NSB Engineering Design and Fabrication; and
- (7) Double J Agri Supply;

WHEREAS, on *05 December 2022*, the Pre-Procurement Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, on *15 December 2022*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder participated namely, **INCA PHILIPPINES, INC.;**

WHEREAS, on 27 December 2022, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein two bidders submitted their bid envelopes namely: **(1) INCA PHILIPPINES, INC. (Lot 1 & 3)** and **(2) DOUBLE J AGRY SUPPLY (Lot 1 & 3)**, while **no bids received for Lot 2;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted, both bidders/suppliers was declared "PASSED" and eligible for the opening of the financial bid envelopes;

WHEREAS, financial bid envelopes were opened and bids were read and tabulated as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidders/suppliers, the BAC declared **DOUBLE J AGRY SUPPLY** offered the lowest bid as read for Lot 1 & 3 for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last 27 December 2022, it was proposed that **DOUBLE J AGRY SUPPLY** be declared as the **Lowest Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, on 28 December 2022, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **DOUBLE J AGRY SUPPLY**, being the *Lowest Calculated Responsive Bidder*;

WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **DOUBLE J AGRY SUPPLY**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. 2022-63** entitled **"SUPPLY AND DELIVERY OF POST-HARVEST EQUIPMENT FOR DISTRIBUTION TO REGIONS 5,6,7,8 & 9" (Lot 1 & 3)**, be awarded to **DOUBLE J AGRI SUPPLY** in the total amount of **Three Million Five Hundred Thousand Five Hundred pesos (₱ 3,500,500.00)** for being the bidder who offered the *Lowest Calculated and Responsive Bid*;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidders, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
