## CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this \_\_\_\_ day of \_\_\_\_\_ 2022 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **DOUBLE J AGRI SUPPLY** of *Ben Saturno Avenue, Brgy. Sibut, San Jose City, Nueva Ecija* (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Bid Reference No. 2022-63 (Lot 1, 2, & 3)** entitled "**SUPPLY AND DELIVERY OF POST HARVEST EQUIPMENT FOR DISTRIBUTION TO REGIONS 5,6,7,8 & 9**" and has accepted a Bid by the Supplier for the supply of those goods and services for Lot 1 and Lot 3 in the total sum of **THREE MILLION FIVE HUNDRED THOUSAND FIVE HUNDRED PESOS (P 3,500,500.00) ONLY** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);

- i. Schedule of Requirements;
- ii. Technical Specifications;
- iii. General and Special Conditions of Contract; and
- iv. Supplemental or Bid Bulletins, if any

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

3. In consideration for the total sum (Lot 1 & 3) of **THREE MILLION FIVE HUNDRED THOUSAND FIVE HUNDRED PESOS (P 3,500,500.00)** or such other sums as may be ascertained, **DOUBLE J AGRI SUPPLY** agrees to execute in accordance with his/her/its Bid.
4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


