A Resolution recommending Award of the Contract for Bid Reference No. 2022-65 entitled "SUPPLY, DELIVERY, FABRICATION, AND INSTALLATION OF HDPE CAGES UNDER OPERATION AND MANAGEMENT OF PRODUCTION FACILITIES (ESTABLISHMENT OF AGRO BUSINESS CORRIDOR FRESHWATER AQUACULTURE IN TAGUIG CITY) PART I" to INCA PHILIPPINES, INC. FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER.

WHEREAS, on 05 December 2022, the Pre-Procurement Conference for the Procurement Project for the below-listed Purchase Requests was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot and with a total Approved Budget for the Contract (ABC) amounting to Thirteen Million Seven Hundred Thirty Thousand Pesos Only (P 13,730,000.00) and posted at the websites of the Philippine Government Electronic Procurement Service (PhilGEPS) with Reference No. 9324174 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

whereas, only Inca Philippines, Inc., a prospective bidder, viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph);

- WHEREAS, on 14 December 2022, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only Inca Philippines, Inc. participated;
- WHEREAS, a Notice of Postponement was issued notifying all prospective bidders that the scheduled Bid Opening on 26 December 2022 was re-scheduled to 27 December 2022 in relation to the Proclamation No. 115 declaring 26 December 2022 as a special (non-working) day throughout the country;
- WHEREAS, on 27 December 2022, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City attended by Inca Philippines, Inc.;
- WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by Inca Philippines, Inc. were "PASSED" and declared eligible for the opening of the financial bid envelope;
- WHEREAS, the financial bid envelope submitted was opened and Inca Philippines, Inc. bid offer is Thirteen Million Seven Hundred Eighteen Thousand Five Hundred Pesos Only (\$\mathbb{P}\$13,718,500.00);
- whereas, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared Inca Philippines, Inc. offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;
- WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG), it was proposed that Inca Philippines, Inc. be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post Qualification procedure;
- WHEREAS, the Technical Working Group (TWG) recommended in the postqualification report that the award for procurement project be awarded to Inca Philippines, Inc., being the Single Calculated Responsive Bidder;
- WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to Inca Philippines, Inc.;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2022-65 entitled "SUPPLY, DELIVERY, FABRICATION, AND INSTALLATION OF HDPE CAGES UNDER OPERATION AND MANAGEMENT OF PRODUCTION FACILITIES (ESTABLISHMENT OF AGRO BUSINESS CORRIDOR FRESHWATER AQUACULTURE IN TAGUIG CITY) PART I", be awarded to INCA PHILIPPINES, INC. in the amount of THIRTEEN MILLION SEVEN HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED PESOS ONLY (\$\mathbb{P}\$13,718,500.00) for being the bidder who offered the Single Calculated and Responsive Bid;

**RESOLVED FINALLY** that the Notice of Award be issued to the above-stated bidders, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
