RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2022-62, ENTITLED "SUPPLY AND INSTALLATION OF ERV UNITS AND DUCTWORKS; AND DESIGN AND INSTALLATION OF AIRCON DUCTING FOR DUCTED TYPE ACU" TO JPACER CONSTRUCTION SERVICES. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. **22-11-1226** pertains to the SUPPLY AND INSTALLATION OF ERV UNITS AND DUCTWORKS; AND DESIGN AND INSTALLATION OF AIRCON DUCTING FOR DUCTED TYPE ACU for the Bureau of Fisheries and Aquatic Resources (BFAR) with an Approved Budget for the Contract amounting to Php **22,900,796.52**;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9301088, the Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on December 09, 2022 (Friday) at 10:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by JPACER Construction Services;

WHEREAS, the opening of bids was conducted last December 21, 2022 (Wednesday), 10:00 am via Zoom and was only participated by JPACER Construction Services;

WHEREAS, during the opening of the Eligibility and Technical Envelopes the abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

WHEREAS, after the opening of the Financial documents, the copy of the Technical and Financial envelopes of the qualified bidder was turned-over to the Technical Working Group (TWG) for post- bid evaluation;

WHEREAS, the TWG conducted Post-Qualification Evaluation to Star Special Corporate last December 27, 2022 and verified the authenticity of the documents submitted;

WHEREAS, in the Post-Qualification Report submitted by the TWG dated January 03, 2023 the TWG recommended the award be given to **JPACER Construction Services** for being the Single Calculated and Responsive Bidder;

WHEREAS, a copy of the said report is hereby made an integral part of the Resolution;

WHEREAS, the BAC, upon due consideration on the Report of the TWG, resolved to adopt the same and recommend the awarding of contract to **JPACER CONSTRUCTION SERVICES** for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project entitled "SUPPLY AND INSTALLATION OF ERV UNITS AND DUCTWORKS; AND DESIGN AND INSTALLATION OF AIRCON DUCTING FOR DUCTED TYPE ACU" is recommended to be awarded to JPACER CONSTRUCTION SERVICES for being the Single Calculated & Responsive Bid in the amount of TWENTY-TWO MILLION EIGHT HUNDRED NINETY-SIX THOUSAND NINE HUNDRED THREE AND 43/100 PESOS (Php 22,896,903.43) ONLY.

RESOLVED FINALLY that, the Notice of Award be issued to **JPACER Construction Services** for the preparation of the Contract Agreement, Notice to Proceed and commencement to the project.


