CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this ____ day of _____ 2023 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **OTUS COPY SYSTEMS, INC.** of **10F MG Tower, 75 Shaw Blvd., Brgy. Daang-Bakal, Mandaluyong City** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly for **Lot No. 1 with Bid Reference No. 2022-66** entitled "**SUPPLY AND DELIVERY OF PRINTER AND PRINTER INKS FOR BFAR CENTRAL OFFICE**", has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SIX HUNDRED FORTY-ONE THOUSAND FOUR HUNDRED TWENTY PESOS ONLY (₱1,641,420.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
