## "CONSTRUCTION OF POWER SUPPLY FOR MULTI-MISSION CENTER AT CORON, PALAWAN"

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DABFAR), through the General Appropriations Act for 2023 intends to apply the sum of One Million Nine Hundred Thirty Thousand Seven Hundred Forty-nine Pesos and Sixty-five Centavos (₱ 1,930,749.65) being the Approved Budget for the Contract (ABC) to payment under the contract for Bid Reference No. 2023–18 entitled "CONSTRUCTION OF POWER SUPPLY FOR MULTI-MISSION CENTER AT CORON, PALAWAN".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- **2.** The DA BFAR now invites bids for the above Procurement Project. Completion of the Works is required within *sixty (60) calendar days* upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- **4.** Interested bidders may obtain further information from *DA BFAR Bids and Awards Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from **8:00** AM to **5:00** PM, Monday to Friday.

- **11.** The DA BFAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
