AMENDMENT AGREEMENT NO. 1

THIS AGREEMENT made the ___ day of 20 DEC 2022 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **LTS RETAIL SPECIALISTS, INC.** of Gempesaw Street, Davao City, Davao Del Sur, Region XI, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for Lot No. 4 with **BID REFERENCE NO. 2022 - 56** entitled "**SUPPLY AND DELIVERY OF YEAR - END ANNUAL SUPPLIES OF HAM, RICE AND FOOD BASKET FOR BFAR - NMC EMPLOYEES AT PANABO CITY, DAVAO DEL NORTE**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO HUNDRED SIXTY THOUSAND SEVEN HUNDRED TEN PESOS ONLY (Php260,710.00)** (hereinafter called "the Contract Price").
