**CONTRACT AGREEMENT FOR GOODS & SERVICES**

THIS AGREEMENT made the \_\_\_ day of JAN 10 2023, 2023 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** of 905 Phil-AM EDSA, Quezon City, Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **Lot No. 4 with BID REFERENCE NO. 2022 - 61** entitled "**SUPPLY AND DELIVERY OF 16 HORSEPOWER MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 390 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTIONS NATIONWIDE**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ELEVEN MILLION THREE HUNDRED TEN THOUSAND PESOS ONLY (PhP11,310,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

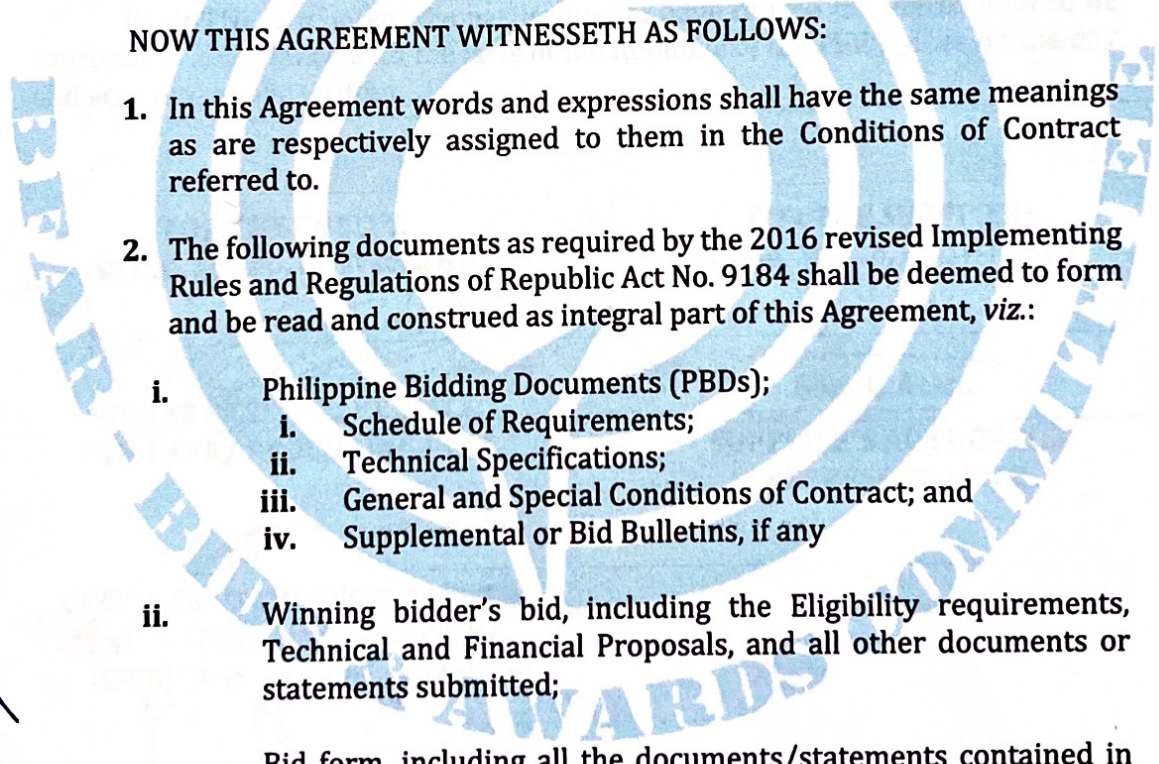



In consideration for the sum of **ELEVEN MILLION THREE HUNDRED TEN THOUSAND PESOS ONLY (PhP11,310,000.00)** or such other sums as may be ascertained, **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** agrees to **BID REFERENCE NO. 2022 - 61** entitled **"SUPPLY AND DELIVERY OF 16 HORSEPOWER MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 390 UNITS 30 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTIONS NATIONWIDE"** in accordance with his/her/its Bid.
4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





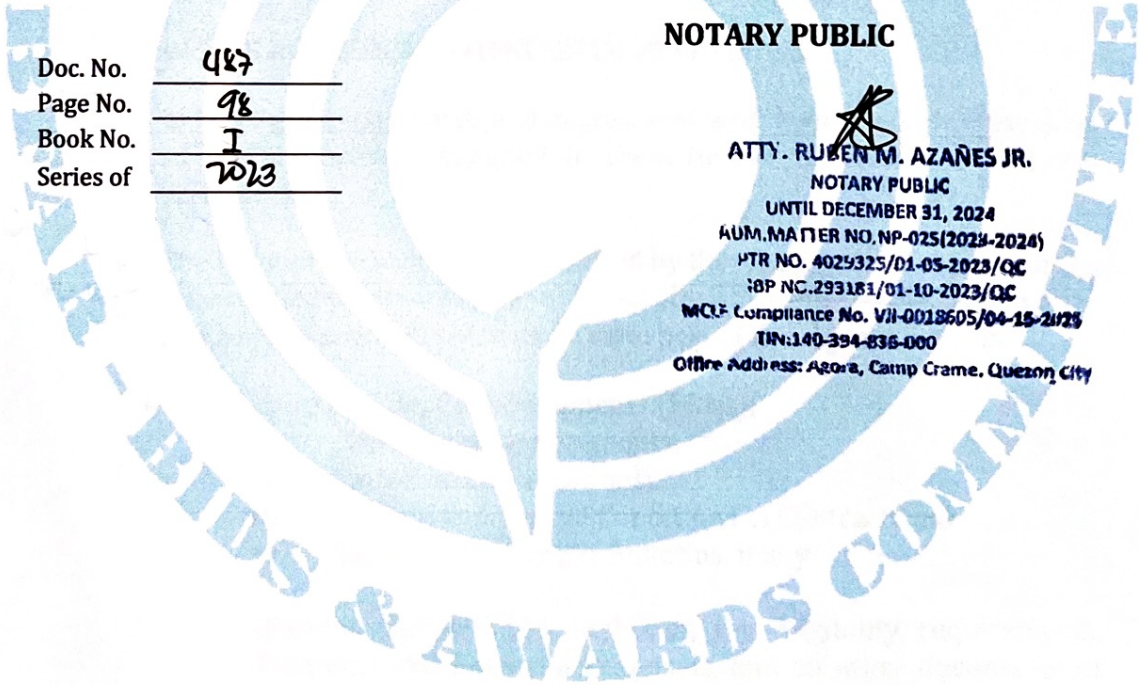
