CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the ___ day of 24 FEB 2023 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **PROPMECH CORPORATION** of Marine Technology Center Building, A. Soriano Corner Arzobispo St., Intramuros, Manila 1002, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **BID REFERENCE NO. 2022 - 64** entitled "**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING SPARE PARTS FOR DA - BFAR MMOV 5001 AND 5002**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FORTY - TWO MILLION THREE HUNDRED THOUSAND PESOS ONLY (PhP 42,300,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of FORTY - TWO MILLION THREE HUNDRED THOUSAND PESOS ONLY (PhP 42,300,000.00) or such other sums as may be ascertained, PROPMECH CORPORATION agrees to BID REFERENCE NO. 2022 - 64 entitled "SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING SPARE PARTS FOR DA - BFAR MMOV 5001 AND 5002" in accordance with his/her/its Bid.
 4. The BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




