**RESOLUTION NO.: 2022 - 64**

**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT OF BID REFERENCE NO. 2022 - 64 ENTITLED "SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING SPARE PARTS FOR DA - BFAR MMOV 5001 AND 5002".**

**WHEREAS,** the Bureau of Fisheries and Aquatic Resources - Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the procurement project entitled "**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING SPARE PARTS FOR DA - BFAR MMOV 5001 AND 5002**" (herein referred to as "Procurement Project") consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), in the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** on 14<sup>th</sup> day of December 2022, Wednesday at 11:00 A.M. the Pre-bidding Conference for the Procurement Project was held through video-conferencing via "Zoom" application;

**WHEREAS,** there were three (3) bidders attended in the said Pre-Bid conference:

1. **ALL CERTIFIED EQUIPMENT TRADING CORPORATION;**
2. **ST. CHRIST INTERNATIONAL TRADING; and**
3. **PROPMECH CORPORATION;**

**WHEREAS,** on 20<sup>th</sup> day of December 2022, Tuesday, the BAC posted a Supplemental/Bid Bulletin No. 1 & 2, amending and clarifying information in the bidding documents, that were posted on the PhilGEPS and BFAR website for at least seven (7) consecutive calendar days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184;

**WHEREAS,** on 26<sup>th</sup> day of December 2022, Monday at 11:00 A.M., the opening of bids for the Procurement Project was held through video-conferencing via "Zoom" application;

**WHEREAS,** in the said Bid Opening, there were two (2) bidders submitted their bid envelopes namely:

1. **ALL CERTIFIED EQUIPMENT TRADING CORPORATION; and**

## 2. PROPMECH CORPORATION;

**WHEREAS,** in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, the above-mentioned bidders were "PASSED" and declared eligible for the opening of the financial bid envelopes;

**WHEREAS,** during the opening of the financial bid envelopes submitted by the bidders its bids were read and tabulated as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidders, the BAC declared the offer of **PROPMECH CORPORATION** as Lowest bid as read, the said procurement project will be subjected to post bidding evaluation and post qualification process to be conducted by the Technical Working Group (TWG);

**WHEREAS,** the BAC ordered the BAC Secretariat to forward the copies of the Eligibility, Technical and Financial envelopes of the bidder/s to the TWG for detailed evaluation and post-qualification process;

**WHEREAS,** the TWG submitted the bid evaluation report stating *inter alia* their recommendation for the conduct of the post-qualification process on the offer of **PROPMECH CORPORATION**;

**WHEREAS,** the post qualification documents submitted by the Lowest calculated and responsive bidder/s were transmitted to the TWG;

**WHEREAS,** the TWG recommended in the post qualification report to award the Procurement Project to **PROPMECH CORPORATION** for being the Lowest Calculated and Responsive Bidder;

**WHEREAS,** the BAC, after due consideration on the report of the TWG, resolved to adopt the same and recommend the awarding of contract to **PROPMECH CORPORATION**;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the Committee hereby recommends that the procurement of the project with **Bid Reference No. 2022-64** entitled "**SUPPLY, DELIVERY AND INSTALLATION OF DIESEL MARINE GENERATOR SET WITH FAST MOVING SPARE PARTS FOR DA - BFAR MMOV 5001 AND 5002**", be awarded to **PROPMECH CORPORATION**, for being the bidder who offered the Lowest Calculated and Responsive Bid in the total amount of **FORTY - TWO MILLION THREE HUNDRED THOUSAND PESOS ONLY (PhP 42,300,000.00)** and the Notice of Award be issued to **PROPMECH CORPORATION**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Goods;


