CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made the ___ day of APR 04 2023 2023 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** of 905 Phil-AM EDSA, Quezon City, Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **Lot No. 4** with **BID REFERENCE NO. 2023 - 03** entitled "**SUPPLY AND DELIVERY OF 7.5 HORSEPOWER MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 350 UNITS 20 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **EIGHT MILLION NINE HUNDRED FORTY - TWO THOUSAND FIVE HUNDRED PESOS ONLY (PhP8,942,500.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **EIGHT MILLION NINE HUNDRED FORTY - TWO THOUSAND FIVE HUNDRED PESOS ONLY (PhP8,942,500.00)** or such other sums as may be ascertained, **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** agrees to **BID REFERENCE NO. 2023 - 03** entitled "**SUPPLY AND DELIVERY OF 7.5 HORSEPOWER MARINE GASOLINE ENGINE FOR THE CONSTRUCTION OF 350 UNITS 20 - FOOTER FRP BOATS FOR THE LIVELIHOOD INTERVENTION NATIONWIDE**" in accordance with his/her/its Bid.
 4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






