1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **ONE MILLION EIGHT HUNDRED FIFTY-ONE THOUSAND FIVE HUNDRED EIGHTY-FIVE AND 60/100 PESOS (Php 1,851,585.60) ONLY** or such other sums as may be ascertained **ATWORK MANPOWER AND GENERAL SERVICES** agrees to the project **HIRING OF JANITORIAL SERVICES FOR BFAR-NMC OFFICES FROM MAY 1, 2023 TO DECEMBER 31, 2023** in accordance with his/her/its Bid.

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


