## CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this \_\_\_\_ day of \_\_\_\_\_ 2023 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **AXZEEN SECURITY AGENCY** Lot 2 Blk 14, Phase 1 Diho Subd., Buhangin, Davao City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **2023-15 entitled HIRING OF SECURITY SERVICES FOR THE PERIOD OF MAY 1, 2023 TO DECEMBER 31, 2023 AT THE BFAR- NATIONAL MARICULTURE CENTER** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIVE MILLION SEVENTY-SEVEN THOUSAND ONE HUNDRED FIFTY-SIX AND 32/100 PESOS (Php 5,077,156.32) ONLY** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid),

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **FIVE MILLION SEVENTY-SEVEN THOUSAND ONE HUNDRED FIFTY-SIX AND 32/100 PESOS (Php 5,077,156.32) ONLY** or such other sums as may be ascertained **AXZEEN SECURITY AGENCY** agrees to the project **HIRING OF SECURITY SERVICES FOR THE PERIOD OF MAY 1, 2023 TO DECEMBER 31, 2023 AT THE BFAR- NATIONAL MARICULTURE CENTER** in accordance with his/her/its Bid.

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


