CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this 30th day of JUN 2023 QUEZON CITY 2023 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **NAVNAUTICS PHILS. INC.** of *G/F Josefa Annex Bldg., 1323 M. Naval St., Brgy. San Roque, Navotas City* (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, for **Bid Reference No. 2023-10A (Re-Bidding)** entitled "**PROCUREMENT OF ELECTRO-HYDRAULIC STEERING GEAR SYSTEM, AND AUXILIARY MACHINERIES OF PATROL VESSELS**", has accepted a Bid by the Supplier for the supply of those goods and services in the total sum of **TEN MILLION THREE HUNDRED THOUSAND NINE HUNDRED EIGHTY-TWO PESOS AND 44/100 ONLY (P10,300,982.44)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
