**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-17, ENTITLED "RENOVATION OF ROOFING AND REPAINTING OF EXTERIOR AND INTERIOR WALLS" TO F.A. ASPRER CONSTRUCTION FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER**

**WHEREAS,** Purchase Request No. **23-03-226** pertains to the Renovation of Roofing and Repainting of Exterior and Interior Walls for FY 2023 with an Approved Budget for the Contract amounting to Php 1,754,494.26;

**WHEREAS,** the abovementioned requests is intended for the MFD-VOC Training facility and MRG office in Sangley Point in Cavite City;

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9589368, the Bureau's website ([www.bfar.gov.ph](http://www.bfar.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** on March 21, 2023 (Tuesday) at 10:00 am, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;

**WHEREAS,** on March 27, 2023 (Monday) at 9:00 am, the Pre-Bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by **F.A. Asprer Construction**;

**WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), namely:

**WHEREAS,** on April 11, 2023 (Tuesday) at 9:00 am, the Bid opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by the lone bidder **F.A. Asprer Construction**;

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **F.A. Asprer Construction** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

**WHEREAS,** in the detailed Bid Evaluation Report submitted by the Technical Working Group (TWG), it was proposed that **F.A. Asprer Construction** be declared as the *Single Calculated and Responsive Bidder* and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** the Technical Working Group (TWG) recommended in the Post Qualification Report that the procurement project be awarded to **F.A. Asprer Construction** for being the *Single Calculated Responsive Bidder*;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the procurement of the project with Bid Reference No. 2023-17 entitled "RENOVATION OF ROOFING AND REPAINTING OF EXTERIOR AND INTERIOR WALLS", be awarded to **F.A. ASPRER CONSTRUCTION** in the amount of ONE MILLION SEVEN HUNDRED THIRTY-SEVEN THOUSAND FOUR HUNDRED NINETY-EIGHT PESOS AND 83/100

(Php 1, 737, 498.83) for being the bidder who offered the **Single Calculated and Responsive Bid**;

**RESOLVED FINALLY** that the Notice of Award be issued to **the above-stated bidder**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Service.


