RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-19, ENTITLED "SUPPLY, DELIVERY AND INSTALLATION OF DUPLEX CONVENIENCE OUTLET, MAIN TO SUB-MAIN DISTRIBUTION CABLE AND 6-STOPS ELEVATOR" TO JPACER CONSTRUCTION SERVICES FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER

WHEREAS, Purchase Request No. 23-03-306 pertains to the Supply, Delivery and Installation of Duplex Convenience Outlet, Main to Sub-main Distribution Cable and 6-stops Elevator for FY 2023 with an Approved Budget for the Contract amounting to Php 13,591,831.73;

WHEREAS, the abovementioned requests is intended for the NFRDI Office and Laboratory Building;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9636126, the Bureau's website (www.bfar.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

WHEREAS, on March 31, 2023 (Friday) at 01:00 pm, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;

WHEREAS, on April 11, 2023 (Tuesday) at 01:30 pm, the Pre-Bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by **Jpacer Construction Services**;

WHEREAS, the following bidders, viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph), namely:

WHEREAS, on April 24, 2023 (Monday) at 01:30 pm, the Bid opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by the lone bidder **Jpacer Construction Services**;

WHEREAS, during the opening of the Eligibility and Technical Envelopes abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **Jpacer Construction Services** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification processes to be conducted by the TWG;

WHEREAS, in the detailed Bid Evaluation Report submitted by the Technical Working Group (TWG), it was proposed that **Jpacer Construction Services** be declared as the *Single Calculated and Responsive Bidder* and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, the Technical Working Group (TWG) recommended in the Post Qualification Report that the procurement project be awarded to **Jpacer Construction Services** for being the *Single Calculated and Responsive Bidder*;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2023-19 entitled "SUPPLY,

DELIVERY AND INSTALLATION OF DUPLEX CONVENIENCE OUTLET, MAIN TO SUB-MAIN DISTRIBUTION CABLE AND 6-STOPS ELEVATOR", be awarded to JPACER CONSTRUCTION SERVICES in the amount of THIRTEEN MILLION FIVE HUNDRED EIGHTY-SEVEN THOUSAND THREE HUNDRED TEN PESOS AND 81/100 (Php 13,587,310.81) for being the bidder who offered the Single Calculated and Responsive Bid;

RESOLVED FINALLY that the Notice of Award be issued to **the above-stated bidder**, for the preparation of the contract agreement, Notice to Proceed and commencement of the delivery of the Service.
