A Resolution recommending Award of the Contract for Bid Reference No. 2023-22 entitled "SUPPLY, DELIVERY, AND INSTALLATION OF SOLAR INVERTER/HYBRID BATTERY IN MULTI-MISSION CENTER (MMC) IN SITIO CARBON, LAJALA, CORON, PALAWAN" to AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. for being the Single Calculated and Responsive Bidder.

WHEREAS, on 31 March 2023, the Pre-Procurement Conference for the Procurement Project of the below-listed Purchase Request was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City:

WHEREAS, the above Purchase Request is needed to replace the dilapidated solar inverter/hybrid battery in Multi-Mission Center (MMC) located at Sitio Carbon, Lajala, Coron, Palawan;

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot and with an Approved Budget for the Contract (ABC) amounting to Three Million One Hundred Fifteen Thousand Pesos (♣ 3, 115,000.00) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 9646646 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;

- WHEREAS, on 19 April 2023, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein four (4) bidders participated namely: 1) SUPERSERVE CORPORATION; 2) ZANEYA BUILDERS AND SUPPLY; 3) AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC.; and 4) EDREY ELECTRICAL SERVICES;
- WHEREAS, eleven (11) prospective bidders viewed the invitation posted at the Philgeps website (www.philgeps.gov.ph) namely: 1) SUPERSERVE CORPORATION; 2) AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC.; 3) SHERIDAN MARKETING, INC.-BACOLOD; 4) TCCPOWERSERVE TRADING AND ENGINEERING SERVICES; 5) TECHNOZONE CORPORATION; 6) OCEAN DE AZUL HOSPITALITY SCHOOL, INC.; 7) LCTSI-LEAD CORE TECHNOLOGY SYSTEM, INC.; 8) SHAKESVILLE ENTERPRISES; 9) SOUTHLAKE HEAVY INDUSTRIES, INC.; 10) PHOTOVOLTAIC SOLAR CENTRE; and 11) EQUILAST, INC.
- whereas, on 02 May 2023, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder submitted its bid envelopes namely AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC.;
- whereas, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. was declared "PASSED" and eligible for the opening of the financial bid envelope;
- WHEREAS, the financial bid envelope submitted was opened and AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. bid offer is Three Million Ninety-two Thousand Forty Pesos (₱ 3,092,040.00) only:
- whereas, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;
- WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last 08 May 2023, it was proposed that AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS. on 22 May 2023, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC., being the Single Calculated Responsive Bidder;

WHEREAS. the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **AUTOMATION SPECIALISTS AND POWER EXPONENTS**. INC.;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2023-22 entitled "SUPPLY. DELIVERY, AND INSTALLATION OF SOLAR INVERTER/HYBRID BATTERY IN MULTI-MISSION CENTER (MMC) IN SITIO CARBON, LAJALA, CORON, PALAWAN" be awarded to AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. in the amount of Three Million Ninety-two Thousand Forty Pesos (₱3,092,040.00) for being the bidder who offered the Single Calculated and Responsive Bid;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
