## CONTRACT AGREEMENT FOR GOODS & SERVICES

THIS AGREEMENT made on this \_\_\_\_ day of \_\_\_\_\_ 2023 between the **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **T.M. DE GUZMAN ENTERPRISES & SERVICES** of 090 Alima Street, Alima Bacoor City, Cavite (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, for **Bid Reference No. 2023-23** entitled "**SUPPLY AND DELIVERY OF PAINTS AND THINNERS NEEDED FOR THE MAINTENANCE OF 14 UNITS MCS PATROL VESSEL, 2 UNITS MMOV AND 1 UNIT F/V TAMBAKOL**", has accepted a Bid by the Supplier for the supply of those goods and services in the total sum of **ONE MILLION ONE HUNDRED FORTY THOUSAND SEVEN HUNDRED PESOS ONLY (Php1,140,700.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or

4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
