A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-25 ENTITLED "CONSTRUCTION OF FRESHWATER AQUACULTURE PARK MULTI-PURPOSE HALL IN BARANGAY HAGONOY, TAGUIG CITY" TO ALVCO TRADING AND CONTRACTOR FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER

- WHEREAS, the Purchase Request No. 23-04-399 pertains to the Construction of Freshwater Aquaculture Park Multi-Purpose Hall in Barangay Hagonoy, Taguig City with an Approved Budget for the Contract amounting to Php 3,000,000.00;
- WHEREAS, the above-mentioned request is a component for the operation of Taguig Agro-Industrial Hub for Freshwater Aquaculture and Urban Farming which manages by the BFAR-NCR;
- whereas, the BFAR Bids and Awards Committee advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9780389, the Bureau's website (www.bfar.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;
- whereas, on May 5, 2023 (Friday) at 11:00 am, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;
- WHEREAS, on May 29, 2023 (Monday) at 10:00 am, the Pre-Bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by Alvco Trading and Contractor;
- **WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph), namely:

WHEREAS, on June 13, 2023 (Monday) at 10:00 am, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by the lone bidder Alvco Trading and Contractor;

WHEREAS, during the opening of the Eligibility and Technical Envelopes, the abovementioned bidder "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

WHEREAS, during the opening of the Financial Documents of the above-mentioned bidder, its bid proposal "As Read" are as follows:

whereas, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared Alvco Trading and Contractor offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed Bid Evaluation Report submitted by the Technical Working Group (TWG), it was proposed that Alvco Trading and Contractor be declared as the Single Calculated and Responsive Bidder and therefore recommend to proceed in the conduct of Post Qualification procedure;

WHEREAS, the Technical Working Group (TWG) recommended in the Post Qualification Report that the award for procurement project be awarded to Alvco Trading and Contractor for being the Single Calculated and Responsive Bidder;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2023-25 entitled "CONSTRUCTION OF FRESHWATER AQUACULTURE PARK MULTI-PURPOSE HALL IN BARANGAY HAGONOY, TAGUIG CITY", be awarded to ALVCO TRADING AND CONTRACTOR in the amount of TWO MILLION NINE HUNDRED SEVENTY-NINE THOUSAND NINE HUNDRED SEVENTY-TWO PESOS AND 13/100 (Php 2,979,972.13) for being the bidder who offered the Single Calculated and Responsive Bid;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder for the preparation of the Contract Agreement, Notice to Proceed and commencement of the Service;
