A Resolution recommending Award of the Contract for Bid Reference No. 2023-28 entitled "ELECTRICAL ENHANCEMENT OF MCS STATION FACILITY AT BFAR NAVOTAS" to MULTI-FOLD LINKS, INC. for being the Single Calculated and Responsive Bidder.

WHEREAS, on 15 May 2023, the Pre-Procurement Conference for the Procurement Project of the below-listed Purchase Request was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City:

WHEREAS, the above Purchase Request is needed due to the increase demand of electricity at BFAR MCS Station arising from the newly constructed facilities like the dormitory building and Regional Fisheries Management Center (RFMC) which operates 24/7 in monitoring the areas of fishery resources protection and to combat illegal, unreported and unregulated fishing activities (IUUF);

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot and with an Approved Budget for the Contract (ABC) amounting to Twenty-three Million Nine Hundred Ten Thousand Pesos Seven Hundred Forty-three Pesos and Eighty-six Centavos (₱ 23,910,743.86) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 9763782 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for *seven (7)* days;

WHEREAS, on 25 May 2023, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein six (6) bidders participated namely: 1) POWER DIMENSION, INC.; 2) MULTI-FOLD LINKS, INC.; 3) INNOVALITE, INC.; 4) LAPLACE ELECTRIC SOLUTIONS; 5) AKIOSHI TRADING; and (6) MEKANISMO;

WHEREAS, a Supplemental Bid Bulletin was posted at the PhilGEPS, BFAR website and in conspicuous place within the BFAR's premises and sent to all the prospective bidders who attended the Pre-Bidding Conference;

WHEREAS, six (6) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: 1) MULTI-FOLD LINKS, INC.; 2) INNOVALITE, INC.; 3) VIBRANT COMMUNICATIONS, INC.; 4) POWER DIMENSION, INC.; 5) SUPERSERVE CORPORATION; and 6) MZR UNICA, INC.;

WHEREAS, on 06 June 2023, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder submitted its bid envelopes namely **MULTI-FOLD LINKS, INC.;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, **MULTI-FOLD LINKS, INC.** was declared "PASSED" and eligible for the opening of the financial bid envelope;

WHEREAS, the financial bid envelope submitted was opened and **MULTI-FOLD LINKS, INC.** bid offer is **Twenty-three Million Seven Hundred Twenty Thousand Pesos (₱ 23, 720, 000.00)** only;

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **MULTI-FOLD LINKS, INC.** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG) last 13 June 2023, it was proposed that **MULTI-FOLD LINKS, INC.** be declared as the **Single Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, on 29 June 2023, the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **MULTI-FOLD LINKS, INC.**, being the *Single Calculated Responsive Bidder*;

WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **MULTI-FOLD LINKS, INC.**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. 2023-28** entitled "**ELECTRICAL ENHANCEMENT OF MCS STATION FACILITY AT BFAR NAVOTAS**" be awarded to **MULTI-FOLD LINKS, INC.** in the amount of **Twenty-three Million Seven Hundred Twenty Thousand Pesos (₱ 23, 720, 000.00)** for being the bidder who offered the *Single Calculated and Responsive Bid*;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
