"CONSTRUCTION OF POWER SUPPLY LINE FOR MULTI-MISSION CENTER IN CORON, PALAWAN"

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DABFAR), through the General Appropriations Act for 2023 intends to apply the sum of Two Million Nine Hundred Twenty Thousand Five Hundred Eight Pesos and Ninety-one Centavos (₱ 2,920,508.91) being the Approved Budget for the Contract (ABC) to payment under the contract for Bid Reference No. 2023–31A (Re-bidding) entitled "CONSTRUCTION OF POWER SUPPLY LINE FOR MULTI-MISSION CENTER IN CORON, PALAWAN".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The DA BFAR now invites bids for the above Procurement Project. Completion of the Works is required within *ninety (90) calendar days* upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- **4.** Interested bidders may obtain further information from *DA BFAR Bids and Awards Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM, Monday to Friday*.

- 10. Bid opening shall be through video conferencing or webcasting via "Zoom" application. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity and in accordance with the BFAR - BAC procedure for online bidding as stated in the "Annex A, Bidder's kit VII".

The DA BFAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
