**RESOLUTION NO. 2023-21A**

**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-21A ENTITLED "SUPPLY, DELIVERY AND FABRICATION OF VARIOUS FISHING BOATS FOR UPGRADING AND CAPACITATING MUNICIPAL FISHERFOLK NATIONWIDE (RE-BID)" TO THE JOINT VENTURE OF DYNACAST SHIPBUILDING AND REPAIRS AND DYNAMIC POWER & MARINE INDUSTRIAL HARDWARE INC. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID**

**WHEREAS,** Purchase Request No. 23-03-323 pertains to Bid Reference No. 2023-21 with the project title "SUPPLY, DELIVERY AND FABRICATION OF VARIOUS FISHING BOATS FOR UPGRADING AND CAPACITATING MUNICIPAL FISHING BOAT NATIONWIDE" with an Approved Budget for the Contract amounting to **Php 452,400,000.00**;

**WHEREAS,** the abovementioned request is for the fabrication of 62-footer fishing boats for upgrading and capacitating municipal fishing boat nationwide that will be distributed to identified fisherfolk beneficiaries;

**WHEREAS,** the 1<sup>st</sup> bidding resulted into FAILURE due to the disqualification of the prospective bidders as per BAC Resolution no. 2023-21B;

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 9961313, the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), namely:

**WHEREAS,** on July 21, 2023 (Friday) at 1:00 pm, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;

**WHEREAS,** on July 27, 2023 (Tuesday) at 1:30 pm,, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by the following prospective bidders, namely:

- Akioshi Trading
- Amaya Dockyard
- Dynacast Shipbuilding and Repairs Inc.

**WHEREAS,** on August 11, 2023 (Friday) at 10:00 am, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and the following bidders submitted their bids, namely:

- Joint Venture of Dynacast Shipbuilding and Repairs Inc. and Dynamic Power and Marine Industrial Hardware
- Josefa Slipways Inc.

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes the Joint Venture of Dynacast Shipbuilding and Repairs Inc. and Dynamic Power and Marine Industrial Hardware "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** Josefa Slipways Inc. was declared DISQUALIFIED due to the following grounds:

- The submitted proof for SLCC was a joint venture agreement with another company having a 25% share amounting to Php 745,000,000.00 only which does not conform with the 50% of the ABC requirement as per TOR of this project (Reference: NPM 089-2012).
- The bidder failed to submit individually signed certification for the following:
  1. List of at least one available service center/ provider each in Luzon, Visayas and Mindanao
  2. Certificate of authorized dealer/ reseller where the marine engine will be purchased in the Philippines
- The submitted certification from the supplier (completion of delivery with satisfactory performance) from their similar project was a certification issued with their joint venture with other two (2) companies.
- Some pages were not signed by the authorized representative as per requirements on the guidelines of the Bid documents such as Omnibus Sworn Statement.
- Failed to provide brochures for various auxiliary equipment (i.e. life saving equipment listed in the TOR).

- Specification of the magnetic compass was not indicated as per requirement in TOR.

**WHEREAS,** the BAC informed Josefa Slipways Inc. that they have a right to file a Motion for Reconsideration within three (3) calendar days from receipt of the verbal/ notice of disqualification. Subsequently, their Bid Documents were ordered to be re-sealed and will be opened only if the BAC finds meritorious grounds in their Motion for Reconsideration, if any;

**WHEREAS,** Josefa Slipways Inc. did not file for a Motion for Reconsideration;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidders, their respective bid proposals "As Read" are as follows:

AND DYNAMIC POWER AND MARINE INDUSTRIAL HARDWARE** be declared as the *Single Calculated and Responsive Bidder* and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **JOINT VENTURE OF DYNACAST SHIPBUILDING AND REPAIRS INC. AND DYNAMIC POWER AND MARINE INDUSTRIAL HARDWARE** for being the *Single Calculated Responsive Bidder*;
