CONTRACT AGREEMENT FOR THE PROCUREMENT GOODS

CONTRACT AGREEMENT

2023 between BUREAU OF THIS AGREEMENT made the FISHERIES AND AQUATIC RESOURCES (BFAR) of the Philippines (hereinafter called "the Entity") of the one part and JOSEFA SLIPWAYS INC. 1326 M. Naval St., San Roque Navotas City, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for BID REFERENCE NO. 2023-35 ENTITLED SUPPLY OF MATERIALS AND LABOR FOR ADDITIONAL DRYDOCKING AND REPAIR WORKS OF M/V DA-BFAR" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THIRTEEN** MILLION ONE HUNDRED FORTY-THREE THOUSAND TWO HUNDRED TWENTY-SEVEN AND 84/100 PESOS ONLY (Php 13,143,227.84) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs); i.
 - Schedule of Requirements;
 - Technical Specifications; ii.
 - General and Special Conditions of Contract; and iii.
 - Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical ii. and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Performance Security; iii.
- Notice of Award of Contract; and the Bidder's conforme thereto; and iv.
- Other contract documents that may be required by existing laws and/or

In consideration for the sum of THIRTEEN MILLION ONE HUNDRED FORTY-THREE THOUSAND TWO HUNDRED TWENTY-SEVEN AND 84/100 PESOS ONLY (Php 13,143,227.84) or such other sums as may be ascertained, JOSEFA SLIPWAYS INC. agrees to BID REFERENCE NO. 2023-35 ENTITLED SUPPLY OF MATERIALS AND LABOR FOR ADDITIONAL DRYDOCKING AND REPAIR WORKS OF M/V DA-BFAR" in accordance with his/her/its Bid.
- 4. The BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
