1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DABFAR), through the General Appropriations Act for 2023 intends to apply the sums of Four Million Four Hundred Four Thousand Five Hundred Forty Three Pesos and 61/100 only (PhP4,404,543.61) being the ABC to payments under the contract for Bid Reference No. 2023 – 40 entitled "SUPPLY AND DELIVERY OF CABLES, SYSTEM PROTECTION, PPE'S AND OTHER MATERIALS FOR MEDIUM VOLTAGE INSTALLATION IN POWERHOUSE OF FISHERIES BUILDING COMPLEX".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DA – BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI - Schedule of Requirements. Bidders should have completed, within five (5) years from the date

of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on <u>October 11, 2023, Wednesday at 09:00 A.M.</u> through video conferencing or webcasting via "Zoom" application. Bids will be opened in

accordance with the BFAR BAC procedure for online bidding as stated in the "Annex A, Bidder's kit VII".

- 10. The DA - BFAR, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
