

INVITATION TO BID FOR BID REFERENCE NO. 2023 - 39

"SUPPLY AND DELIVERY OF 9 HORSEPOWER MARINE GASOLINE ENGINE FOR 142 UNITS 16 - FOOTER FRP "PAKURA" BOATS IN LINE WITH THE "CAPACITATING MUNICIPAL FISHERFOLK PROGRAM"

- The Department of Agriculture Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the General Appropriations Act for 2023 intends to apply the sum of Four Million One Hundred Thirty – Nine Thousand Three Hundred Pesos Only (PhP4,139,300.00) being the ABC to payments under the contract for Bid Reference No. 2023 – 39 entitled "SUPPLY AND DELIVERY OF 9 HORSEPOWER MARINE GASOLINE ENGINE FOR 142 UNITS 16 - FOOTER FRP "PAKURA" BOATS IN LINE WITH THE "CAPACITATING MUNICIPAL FISHERFOLK PROGRAM". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI Schedule of Requirements. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- **3.** Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- **4.** Prospective Bidders may obtain further information from DA BFAR BAC Secretariat and inspect of the Bidding Documents at the address given below during office hours from **8:00 AM** to **5:00 PM**, **Monday to Friday**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 15, 2023 to October 03, 2023 from 8:00 AM to 5:00 PM, Monday to Friday and up to 10:30 AM of October 04, 2023 from the given address and website/s below and upon payment of a non-refundable fee for the Bidding

Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.

- 6. The DA BFAR, will hold a Pre-Bid Conference on <u>September 22, 2023, Friday at 11:00 AM</u> through video conferencing or webcasting via "Zoom" application which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the Pre-bid Conference using Google Form https://docs.google.com/forms/d/e/1FAIpQLScDdch1llxLiAL4STMNFe03wGh WZclVKPVfqVhhbJtWqf1XsQ/viewform?usp=pp url and in accordance with the "Annex A, Bidder's Kit – I".
- Bids must be duly received by the BAC Secretariat through the options given below and as indicated in ITB Clause 15 of this bidding documents, on or before October 04, 2023, Wednesday at 10:30 AM. Late bids shall not be accepted.

- **8.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- **9.** Bid opening shall be on <u>October 04, 2023, Wednesday at 11:00 A.M.</u> through video conferencing or webcasting via "Zoom" application. Bids will be opened in accordance with the BFAR BAC procedure for online bidding as stated in the "Annex A, Bidder's kit VII".
- **10.** The DA BFAR, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
