

RESOLUTION NO.:NP2023-12A.1 (Two Failed Biddings)

A Resolution Recommending Award of the Contract for Bid Reference No. NP2023-12A (Two Failed Biddings) entitled "SUPPLY AND DELIVERY OF BANGUS FRY SIZE 4 (TWO (2) CROPPINGS) IN SUPPORT OF THE OPERATION ON BANGUS FINGERLINGS/GARUNGAN PRODUCTION TECHNO-DEMO IN BRACKISHWATER FISHPOND AT BFAR - NATIONAL MARICULTURE CENTER (NMC), PANABO CITY, DAVAO DEL NORTE" to Davao City Free Farmers Cooperative for being the Single Calculated and Responsive Bidder.

WHEREAS, on *6 July 2023*, the Pre-Procurement Conference for the Procurement Project for the below-listed Purchase Requests was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

WHEREAS, the abovestated Purchase Requests will be used to support the operation on Bangus Fingerlings/ Garungan Production Techno-Demo in Brackishwater Fishpond at BFAR- National Mariculture Center (NMC), Panabo City, Davao del Norte.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot and with a total Approved Budget for the Contract (ABC) amounting to **One Million Five Hundred Fifty Nine Thousand Nine**



Hundred Twenty Nine Pesos only (₱ 1,559,929.00) and posted at the websites of the Philippine Government Electronic Procurement Service (PhilGEPS) with Reference No. 9919113, BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises for *seven (7) days*;

WHEREAS, on *14 July 2023*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, attended by **(1) Davao City Free Farmers Cooperative, (2) Metro Davao Mega Import and Export Trading Corp. ;**

WHEREAS, on *26 July 2023*, the scheduled Opening of Bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City Quezon City, the BFAR BAC opened the bids submitted by **(1) Davao City Free Farmers Cooperative, (2) Metro Davao Mega Import and Export Trading Corp., and (3) Manleonor Aqua Farm** in public and in the presence of the bidder's representatives to determine the latter's compliance with the Eligibility, Technical and Financial requirements specified in the PBD;

WHEREAS, during the preliminary examination of bids, the BFAR BAC examined the submitted eligibility and technical documents of the *three (3)* bidders versus a checklist to ascertain if the required documents were all submitted, using a discretionary pass/fail criterion;

WHEREAS, after the opening of the first (1st) envelope (Eligibility and Technical component) submitted by **Davao City Free Farmers Cooperative**, the BAC declared that the latter was able to submit the required legal, technical, and financial documents/requirements. Consequently, the BAC rated the technical component of Davao City Free Farmers Cooperative's bid as "Passed" while **Manleonor Aqua Farm** and **Metro Davao Mega Import and Export Trading Corp.** were disqualified due to non-compliant on the required documents ;

WHEREAS, the BAC proceeded to open the second envelope (Financial component) of **Davao City Free Farmers Cooperative** whose technical component was rated "Passed";

WHEREAS, the bid-offer of **Davao City Free Farmers Cooperative** is **One Million Four Hundred Seventy Three Thousand Two Hundred Sixty Five Pesos and 90/100 (Php 1,473,265.90)**;



WHEREAS, after due evaluation, the BAC determined that the bid of ***Davao City Free Farmers Cooperative*** is within the ABC.;

WHEREAS, the BAC informed both ***Metro Davao Mega Import and Export Trading Corp.*** and ***Manleonor Aqua Farm*** that they may file a request for reconsideration within *three (3) calendar days*;

WHEREAS, the following disqualified bidders filed their request for reconsideration:

- 1. Metro Davao Mega Import and Export Trading Corporation (July 26, 2023)**
- 2. Manleonor Aqua Farm (July 28, 2023)**

WHEREAS, after due deliberation, the members of the Bids and Awards Committee unanimously agreed and recommends the denial of the Motion for Reconsideration filed by ***METRO DAVAO MEGA IMPORT AND EXPORT TRADING CORPORATION*** due to non-submission of *updated Certificate of PhilGEPS Registration (Platinum Membership) - Annex A.* and ***MANLEONOR AQUA FARM*** due to *incomplete details of notarization on their submitted Omnibus Sworn Statement.*

WHEREAS, on *1 August 2023* a Notice on Denial of Motion for Reconsideration and the BAC Resolution No.NP2023-12A (Two Failed Biddings)Series of 2023 Recommending the Denial of the Motion for Reconsideration was sent to ***Metro Davao Mega Import and Export Trading Corp. and Manleonor Aqua Farm*** ;

WHEREAS, on *9 August 2023*, the TWG submitted the detailed Bid Evaluation Report proposing that ***Davao City Free Farmers Cooperative*** be declared as the Single Calculated Bidder and therefore recommended to proceed in the conduct of the Post Qualification procedure;

WHEREAS, on the same date, a Notice to Conduct Post Qualification was sent to ***Davao City Free Farmers Cooperative***;

WHEREAS, the TWG recommended in the Post Qualification report that the award for the procurement project be awarded to ***Davao City Free Farmers***, being the Single Calculated and Responsive Bid;

WHEREAS, the BAC, upon due consideration of the report of the TWG, resolved to adopt the same and recommend the awarding of the contract to ***Davao City Free Farmers Cooperative***;



NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. NP2023-12A** entitled **“SUPPLY AND DELIVERY OF BANGUS FRY SIZE 4 (TWO (2) CROPPINGS) IN SUPPORT OF THE OPERATION ON BANGUS FINGERLINGS/GARUNGAN PRODUCTION TECHNO-DEMO IN BRACKISHWATER FISHPOND AT BFAR - NATIONAL MARICULTURE CENTER (NMC), PANABO CITY, DAVAO DEL NORTE”**, be awarded to **Davao City Free Farmers Cooperative** in the amount of **One Million Four Hundred Seventy Three Thousand Two Hundred Sixty Five Pesos and 90/100 (Php1,473,265.90)** for being the bidder who offered the **Single Calculated and Responsive Bid**;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.


