**A Resolution Recommending Award of the Contract for Lot No. 1 under Bid Reference No. 2023-36 entitled “SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS AND HATCHERY PARAPHERNALIA FOR THE IMPROVEMENT OF CARP HATCHERY IN JALA-JALA RIZAL FOR THE BREEDING AND CULTURE OF CARPS AND MAJOR CARPS” to MZR BUILDERS for being the Single Calculated and Responsive Bidder and Declaring Failure of Bidding for Lot No. 2 due to no bids received .**

**WHEREAS,** on 26 July 2023, the Pre-Procurement Conference for the Procurement Project for the below-listed Purchase Requests was held via ZOOM at the BFAR BAC Room, 2 /F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City;

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot and with Approved Budget for the Contract (ABC) amounting to **One Million Seven Hundred Sixty-Three Thousand Seventy-FivePesos and 60/100 only (₱ 1,763,075.60)** and posted at the websites of the Philippine Government Electronic Procurement Service(PhilGEPS) with Reference No. 9801317, BFAR

**WHEREAS,** on *07 August 2023*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, attended by **(1) MZR Builders and (2) Evolve Constructions and Supplies;**

**WHEREAS,** on *14 August and 16 August 2023*, the BAC posted a Supplemental/Bid Bulletin No. 1 and No. 2, amending and clarifying information in the bidding documents, that were posted on the PhilGEPS and BFAR website for at least seven (7) consecutive calendar days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184;

**WHEREAS,** on *23 August 2023*, the scheduled Opening of Bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City Quezon City. The BFAR BAC opened the bids submitted by the lone bidder, **MZR Builders** who bid for **Lot No. 1** in public and the presence of the bidder's representatives to determine the latter's compliance with the Eligibility, Technical and Financial requirements specified in the PBD;

**WHEREAS,** during the preliminary examination of bids, the BFAR BAC examined the submitted eligibility and technical documents of **MZR Builders** versus a checklist to ascertain if the required documents were all submitted, using a non-discretionary pass/fail criterion;

**WHEREAS,** after opening the first (1<sup>st</sup>) envelope (Eligibility and Technical component) submitted by **MZR Builders**, the BAC declared that the latter was able to submit the required legal, technical, and financial documents/requirements. Consequently, the BAC rated the technical component of **MZR Builders** bid as "Passed";

**WHEREAS,** for **Lot No. 2**, Section 35.1 of the IRR of RA 9184 states that:

**35.1.** The BAC shall declare the bidding a failure when:

**a) No bids are received;**

*b) All prospective bidders are declared ineligible;*

*c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of consulting services, there is no successful negotiation; or*

*d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR;*

**WHEREAS,** based on the foregoing, the BFAR – BAC resolves that the said project fall under subsection (a) of the afore-quoted provision of law;

**WHEREAS,** the BAC proceeded to open the second envelope (Financial component) of **MZR Builders** whose technical component was rated “Passed”;

**WHEREAS,** the bid-offer of **MZR Builders** is **One Million Six Hundred Forty-Five Thousand Three Hundred Seventy Five Pesos and 93/100 (Php 1,645,375.93)**;

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **MZR BUILDERS** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

**WHEREAS,** the BAC ordered the BAC Secretariat to forward the copies of the Eligibility, Technical and Financial envelopes of the bidder/s to the TWG for detailed evaluation and post-qualification process;

**WHEREAS,** in the detailed bid evaluation report submitted by the Technical Working Group (TWG) it was proposed that **MZR BUILDERS** be declared as the **Single Calculated and Responsive Bid** and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** the post qualification documents submitted by the Single Calculated and Responsive Bidder was transmitted to the TWG;

No. 2023-36** entitled "**SUPPLY AND DELIVERY OF HATCHERY EQUIPMENT**", be declared as a failed bidding due to **No Bids are received** and to undergo Negotiated Procurement under **Section 53.9 Small Value Procurement**, since the Approved Budget for the Contract (ABC) is below One Million Pesos (PhP1,000,000);

The Procurement of the Project for **Lot No. 1** with **Bid Reference No. 2023 -36** entitled "**SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS FOR THE IMPROVEMENT OF CARP HATCHERY IN JALA-JALA RIZAL FOR THE BREEDING AND CULTURE OF CARPS AND MAJOR CARPS**", be awarded to **MZR BUILDERS**, for being the bidder who offered the Single Calculated and Responsive Bid for **Lot No. 1** in the total amount of **One Million Six Hundred Forty-Five Thousand Three Hundred Seventy Five Pesos and 93/100 (Php 1,645,375.93)**;




