A Resolution recommending Award of the Contract for Bid Reference No. 2023-37 entitled “SUPPLY, DELIVERY, AND INSTALLATION OF UNIFIED COMMUNICATIONS MODERNIZATION IN THE NFRDI BUILDING” to MULTI-FOLD LINKS, INC. for being the Single Calculated and Responsive Bidder.

WHEREAS, on *05 September 2023*, the Pre-Procurement Conference for the Procurement Project of the below-listed Purchase Request was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City:

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot and with an Approved Budget for the Contract (ABC) amounting to Nineteen Million Five Hundred Seven Thousand Seven Hundred Fourteen pesos (₱ 19, 507, 714.00) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 10134631 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau’s premises for *seven (7)* days;

WHEREAS, on *22 September 2023*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein two (2) bidders participated namely: 1) MULTI-FOLD LINKS, INC.; and 2) CJ TECHNOLOGY ELECTRONICS;

WHEREAS, eleven (11) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: 1) COSMIC TECHNOLOGIES INCORPORATED; 2) ACCENT MICRO TECHNOLOGIES, INC.; 3) INFOBAHN COMMUNICATIONS, INC. 4) COMWORKS INC.; 5) BUENAFER MARINE SPARE PARTS & SERVICES; 6) MULTI-FOLD LINKS, INC.; 7) SENSATION SOUNDS AND LIGHTS; 8) UM BUSINESS INC. 9) SCAN MARINE INC.; 10) TELECOMMUNICATIONS & COMPUTER TECHNOLOGIES, INC.; and 11) TWD TRADING CORP.

WHEREAS, on *04 October 2023*, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein only one (1) bidder submitted its bid envelopes namely **MULTI-FOLD LINKS, INC.;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, **MULTI-FOLD LINKS, INC.** was declared “PASSED” and eligible for the opening of the financial bid envelope;

WHEREAS, the financial bid envelope submitted was opened and **MULTI-FOLD LINKS, INC.** bid offer is **Nineteen Million Two Hundred Thirteen Thousand Six Hundred Ninety-one pesos and Twenty-four Centavos (₱ 19, 213, 691.24)** only:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **MULTI-FOLD LINKS, INC.** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG), it was proposed that **MULTI-FOLD LINKS, INC.** be declared as the ***Single Calculated and Responsive Bidder*** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, in the post-qualification report submitted by the Technical Working Group (TWG), it was recommended that the award for procurement project be awarded to **MULTI-FOLD LINKS, INC.,** being the ***Single Calculated Responsive Bidder;***

WHEREAS, the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **MULTI-FOLD LINKS, INC.;**

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with **Bid Reference No. 2023-37** entitled "**SUPPLY, DELIVERY, AND INSTALLATION OF UNIFIED COMMUNICATIONS MODERNIZATION IN THE NFRDI BUILDING**" be awarded to **MULTI-FOLD LINKS, INC.** in the amount of **Nineteen Million Two Hundred Thirteen Thousand Six Hundred Ninety-one pesos and Twenty-four Centavos (₱ 19, 213, 691.24)** for being the bidder who offered the *Single Calculated and Responsive Bid;*

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
