A RESOLUTION RECOMMENDING AWARD OF THE CONTRACT OF BID REFERENCE NO. 2023-44 ENTITLED "SUPPLY AND DELIVERY OF MATERIALS FOR LONGLINE MUSSEL CULTURE" TO DOUBLE J AGRI SUPPLY FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid of Purchase Request no. 23-00-1094 with Bid Reference no. 2023-44 entitled "SUPPLY AND DELIVERY OF MATERIALS FOR LONGLINE MUSSEL CULTURE" through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with Reference no.: 1018876, and in Bureau's website (www.bfar.da.gov.ph) and in conspicuous places within the Bureau's premises from October 03, 2023 to October 23, 2023;

WHEREAS, on September 26, 2023, at 11:00 a.m., the Pre-Procurement Conference for the above-mentioned procurement project was conducted at the 2/F BFAR Bldg., BAC Office, BPI Compound, Brgy. Vasra, Visayas Ave., Diliman, Quezon City and via videoconference through "zoom" application;

WHEREAS, on October 11, 2023, at 11:00 a.m., the Pre-Bid Conference for the above-mentioned procurement project was conducted at the 2/F BFAR Bldg., BAC Office, BPI Compound, Brgy. Vasra, Visayas Ave., Diliman, Quezon City and via videoconference through "zoom" application wherein only one (1) bidder/supplier participated namely: *DOUBLE J AGRI SUPPLY*;

WHEREAS, on October 23, 2023, at 10:00 a.m., the Opening of Bids Conference for the above-mentioned procurement project was conducted at the 2/F BFAR Bldg., BAC Office, BPI Compound, Brgy. Vasra, Visayas Ave., Diliman, Quezon City and via videoconference through "zoom" application wherein only (1) one bidder/supplier submitted its bids, namely: *DOUBLE J AGRI SUPPLY*;

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelope submitted by the bidder/supplier was "PASSED" and declared eligible for the opening of the financial bid envelope;

WHEREAS, during the opening of the financial bid envelope submitted by , its bid was read and tabulated as follow:

WHEREAS,

after reading and determining the amount of bid as proposed by the bidder/supplier, the BAC declared that **DOUBLE J AGRI SUPPLY**, offered the single responsive bid as read for the said procurement project and will be subjected to post bidding evaluation and post qualification process to be conducted by the Technical Working Group (TWG);

WHEREAS,

the opened legal and technical and financial copy 3 of bid envelopes were turned-over to the Technical Working Group (TWG) for detailed bid evaluation and post qualification procedure;

WHEREAS,

in the detailed bid evaluation report submitted by the Technical Working Group (TWG) it was proposed that **DOUBLE J AGRI SUPPLY**, be declared as the Single Calculated and Responsive Bidder and therefore recommended to proceed in the conduct of Post-qualification procedure;

WHEREAS,

the BAC issued a Notice of Post-qualification to **DOUBLE J AGRI SUPPLY**. and the latter submitted its Post-qualification documents for review of the Technical Working Group (TWG);

WHEREAS,

in the Post-Qualification Report submitted by the Technical Working Group (TWG), it was proposed that the award for the said procurement project be given to **DOUBLE J AGRI SUPPLY**, for being the Single Calculated and Responsive Bidder (SCRB);

WHEREAS,

a copy of the said Report/Memorandum is hereby made as integral part of this Resolution;

WHEREAS,

the BAC, upon due consideration on the Report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of contract of the said procurement project to **DOUBLE J AGRI SUPPLY**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement project entitled "**SUPPLY AND DELIVERY OF MATERIALS FOR LONGLINE MUSSEL CULTURE**" is recommended to be awarded to **DOUBLE J AGRI SUPPLY**, for being the **SINGLE CALCULATED** and **RESPONSIVE BID** in the amount of **NINE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED THIRTY PESOS ONLY (P 998,530.00)**.

RESOLVED FINALLY that, the Notice of Award be issued to **DOUBLE J AGRI SUPPLY**, for the preparation of the Contract Agreement, Notice to Proceed and commencement to the project.


