

RESOLUTION NO.: PB 2023-45A
Series of 2023

A Resolution recommending Award of the Contract for Bid Reference No. 2023-45A entitled “REPAIR OF ROOF AND CEILING OF BFAR-NSTDC ADMINISTRATIVE BUILDING” to 0405 CONSTRUCTION AND SUPPLY for being the Lowest Calculated and Responsive Bidder.

WHEREAS, the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of *one (1)* lot and with an Approved Budget for the Contract (ABC) amounting to One Million Two Hundred Ninety-three Thousand Five Hundred Eighteen Pesos and Fifty-eight Centavos (₱ 1,293,518.58) and posted at the websites of the Philippine Government Electronic Procurement Service (www.philgeps.gov.ph) with Reference No. 10293374 and BFAR (www.bfar.da.gov.ph) and in conspicuous places within the Bureau’s premises for *seven (7)* days;

WHEREAS, on *16 November 2023*, the Pre-Bid Conference for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein two (2) bidders participated namely: **1) 0405 CONSTRUCTION AND SUPPLY; 2) VEMMIRA CONSTRUCTION SERVICES AND SUPPLIES, INC.;**

WHEREAS, nine (9) prospective bidders viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph) namely: 1) MCJ SUMMIT ENTERPRISE; 2) INFRASMITH BUILDERS; 3) CISCO KVF CONSTRUCTION 4) VEMMIRA CONSTRUCTION AND SUPPLIES INC.; 5) F.A ASPRER CONSTRUCTION 6) MJMT CONSTRUCTION SERVICES; 7) LJDB CONSTRUCTION 8) 0405 CONSTRUCTION AND SUPPLY; AND 9) JEMN BUILDERS;

WHEREAS, on *28 November 2023*, the opening of bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City wherein two (2) bidders submitted its bid envelopes namely **1) 0405 CONSTRUCTION AND SUPPLY; 2) VEMMIRA CONSTRUCTION SERVICES AND SUPPLIES, INC.;**

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, both bidders were declared “PASSED” and eligible for the opening of the financial bid envelope;

WHEREAS, the financial bid envelopes submitted was opened and the bids as read are as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidders/suppliers, the BAC declared **VEMMIRA CONSTRUCTION SERVICES AND SUPPLIES, INC.** offered the lowest bid as read and **0405 CONSTRUCTION AND SUPPLY** as the second lowest bid as read for the said procurement project and will be subjected to post-bidding evaluation to be conducted by the TWG;

WHEREAS, in the detailed bid evaluation report submitted by the Technical Working Group (TWG), after applying the **Two Hundred Thousand pesos (Php 200,000.00)** discount offered by **0405 CONSTRUCTION AND SUPPLY** in their Bid Form, the following is the summary of bids as calculated:

WHEREAS, as shown in the above table, the Technical Working Group proposed that **0405 CONSTRUCTION AND SUPPLY** be declared as the **Lowest Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;

WHEREAS, in the post qualification report, the Technical Working Group (TWG) recommended that the award for procurement project be awarded to **0405 CONSTRUCTION AND SUPPLY**, being the **Lowest Calculated Responsive Bidder**;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
