CONTRACT AGREEMENT

day of DEC 2 9 2023 2023 between BUREAU OF THIS AGREEMENT made the FISHERIES AND AQUATIC RESOURCES (BFAR) of the Philippines (hereinafter called "the Entity") of the one part and JEPA CONSTRUCTION & DEVELOPMENT CORP. B3 Lia Maple Wood East Subdivision Pasong Tamo, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly BID REFERENCE NO. 2023-46 CONSTRUCTION OF BFAR REGIONAL FRESHWATER TECHNOLOGY OUTREACH STATION (Phase 1) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of FIFTY-THREE MILLION THREE HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED SEVENTEEN AND 41/100 PESOS ONLY (Php 53,355,317.41) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or

In consideration for the sum of FIFTY-THREE MILLION THREE HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED SEVENTEEN AND 41/100 PESOS ONLY (Php 53,355,317.41) or such other sums as may be ascertained, JEPA CONSTRUCTION & DEVELOPMENT CORP. agrees to BID REFERENCE NO. 2023-46 CONSTRUCTION OF BFAR REGIONAL FRESHWATER TECHNOLOGY OUTREACH STATION (Phase 1) in accordance with his/her/its Bid.
- 4. The BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
