WHEREAS, on 28 November 2023, the scheduled Opening of Bids for the Procurement Project was held via ZOOM at the BFAR BAC Room, 2/F Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Avenue, Quezon City Quezon City. The BFAR BAC opened the bids submitted by (1) **Navnautics Phils. Inc.** (2) **D.T.S Electronics and Telecommunication Parts and Equipment Retailing** in public and the presence of the bidder’s representatives to determine the latter’s compliance with the Eligibility, Technical and Financial requirements specified in the PBD;

WHEREAS, during the preliminary examination of bids, the BFAR BAC examined the submitted eligibility and technical documents of the *two (2)* bidders versus a checklist to ascertain if the required documents were all submitted, using a discretionary pass/fail criterion;

WHEREAS, in the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes, the above-mentioned bidders were “PASSED” and declared eligible for the opening of the financial bid envelopes;

WHEREAS, during the opening of the financial bid envelopes submitted by the bidders its bids were read and tabulated as follows:

- WHEREAS,** in the detailed bid evaluation report submitted by the Technical Working Group (TWG) it was proposed that **D.T.S ELECTRONICS AND TELECOMMUNICATION PARTS AND EQUIPMENT RETAILING** be declared as the **Lowest Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;
- WHEREAS,** the post qualification documents submitted by the Lowest Calculated and Responsive Bidder was transmitted to the TWG;
- WHEREAS,** the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **D.T.S ELECTRONICS AND TELECOMMUNICATION PARTS AND EQUIPMENT RETAILING**, being the Lowest Calculated Responsive Bidder;
- WHEREAS,** the BAC, upon due consideration of the report of the Technical Working Group (TWG), resolved to adopt the same and recommend the awarding of the contract to **D.T.S ELECTRONICS AND TELECOMMUNICATION PARTS AND EQUIPMENT RETAILING ;**


