RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-51 ENTITLED "HIRING OF DA-BFAR SECURITY SERVICES FOR THE PERIOD OF JANUARY 1, 2024 TO DECEMBER 31, 2024" TO STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC.
