



CONTRACT AGREEMENT FOR INFRASTRUCTURE PROJECTS

CONTRACT AGREEMENT

THIS AGREEMENT made the JAN 09 2024 day of _____ 2023 between BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) of the Philippines (hereinafter called "the Entity") of the one part and JPACER CONSTRUCTION SERVICES Block 28/ Block 29 Lambak Avenue, San Juan, Taytay, Rizal (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for BID REFERENCE NO. 2023-55 "CONSTRUCTION OF ELECTRICAL DISTRIBUTION SYSTEM OF NFRDI BUILDING" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of THIRTY-NINE MILLION NINE HUNDRED SEVENTY-SIX THOUSAND FOUR HUNDRED FIFTY AND 10/100 PESOS ONLY (Php 39,976,450.10) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or

3. The BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
