**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-62 RENOVATION OF BFAR MAIN BUILDING CONFERENCE ROOM TO LARD BUILDERS AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID**

**WHEREAS,** Purchase Request No. 23-11-1567 pertains to the **"RENOVATION OF BFAR MAIN BUILDING CONFERENCE ROOM** with an Approved Budget for the Contract amounting to **Php 2,273,173.93;**

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 10364699, the Bureau's website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau's premises for seven (7) days;

**WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), namely:

**WHEREAS,** on November 24, 2023 (Tuesday) at 02:30 pm, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;

**WHEREAS,** on December 04, 2023 (Monday) at 09:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by Lard Builders;

**WHEREAS,** on December 18, 2023 (Monday) at 09:00 am, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and only Lard Builders submitted their bid;

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes the abovementioned bidder **"PASSED"** the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidder, **"As Read"** is as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **LARD BUILDERS** as the bidder who offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation and post-qualification process to be conducted by the TWG;

**WHEREAS,** in the detailed bid evaluation report submitted by the Technical Working Group (TWG), it was proposed that **LARD BUILDERS** be declared as the **Single Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **LARD BUILDERS** for being the **Single Calculated Responsive Bidder**;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the procurement of the project with **Bid Reference No. 2023-62** entitled **RENOVATION OF BFAR MAIN BUILDING CONFERENCE ROOM** awarded to **LARD BUILDERS** in the amount of **TWO MILLION TWO HUNDRED SEVENTY-THREE THOUSAND ONE HUNDRED SEVENTY-THREE AND 93/100 PESOS ONLY (Php 2,273,173.93)** for being the bidder who offered the **Single Calculated Responsive Bid**.

**RESOLVED FINALLY** that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
