RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-63 SUPPLY, DELIVERY, AND INSTALLATION OF OFFICE FURNITURE AND APPLIANCES FOR BFAR MAIN BUILDING CONFERENCE ROOM AND OFFICE OF THE DIRECTOR TO ENICEO ENTERPRISES AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID

WHEREAS, Purchase Request No. 23-11-1568 pertains to the **“SUPPLY, DELIVERY, AND INSTALLATION OF OFFICE FURNITURE AND APPLIANCES FOR BFAR MAIN BUILDING CONFERENCE ROOM AND OFFICE OF THE DIRECTOR** with an Approved Budget for the Contract amounting to **Php 2,226,826.07;**

WHEREAS, on December 04, 2023 (Monday) at 10:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by Eniceo Enterprises;

WHEREAS, on December 18, 2023 (Monday) at 02:30 pm, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and only Eniceo Enterprises submitted their bid;

WHEREAS, during the opening of the Eligibility and Technical Envelopes the abovementioned bidder **“PASSED”** the evaluation and was declared eligible for the opening of the financial envelopes;






