CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 08 2024 day of 2024 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called the "Entity") and **ZANEYA BUILDERS & SUPPLY** Bahay Pari II, Brgy. Balasing Sta. Maria, Bulacan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **BID REFERENCE NO. 2023-67 "IMPROVEMENT OF FISHCORE OFFICE AT 2ND FLOOR OF NFA BUILDING"** (hereinafter called "the Works") and has accepted the Bid in the sum of **TWO MILLION NINE HUNDRED SEVENTY-ONE THOUSAND EIGHTY-SIX PESOS AND FIFTY-SIX CENTAVOS (Php 2,971,086.56)** for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
 - a. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or

the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **TWO MILLION NINE HUNDRED SEVENTY-ONE THOUSAND EIGHTY-SIX PESOS AND FIFTY-SIX CENTAVOS (Php 2,971,086.56)** or such other sums as may be ascertained, **ZANEYA BUILDERS & SUPPLY** agrees to **BID REFERENCE NO. 2023-67 "IMPROVEMENT OF FISHCORE OFFICE AT 2ND FLOOR OF NFA BUILDING"** in accordance with his/her/its Bid.
4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


