

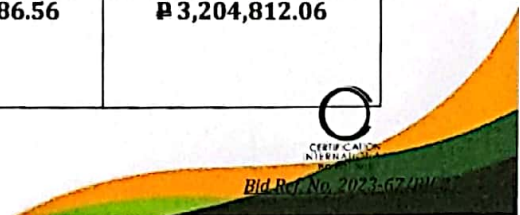


RESOLUTION NO.: 2023-67

A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2023-67 ENTITLED "IMPROVEMENT OF FISHCORE OFFICE AT 2ND FLOOR OF NFA BUILDING" TO ZANEYA BUILDERS & SUPPLY FOR BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER

- WHEREAS,** the Purchase Request No. 23-11-1566 pertains to the Improvement of Fishcore Office at 2nd Floor of NFA Building with an Approved Budget for the Contract amounting to **Php3,443,575.13**;
- WHEREAS,** the above-mentioned request will serve as official station/office for operation and management of BFAR Fishcore Projects;
- WHEREAS,** the BFAR Bids and Awards Committee advertised the Invitation to Bid for the above-mentioned procurement project consisting of a single lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 10374827, the Bureau's website (www.bfar.gov.ph) and in conspicuous places within the Bureau's premises for seven (7) days;
- WHEREAS,** on November 24 (Friday) at 04:30 pm, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;
- WHEREAS,** on December 7, 2023 (Thursday) at 11:00 am, the Pre-Bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by two prospective Bidders: Zaneya Builders & Supply, and Rosand Builders Corporation;
- WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website (www.philgeps.gov.ph), namely:

- WHEREAS,** on December 19, 2023 (Tuesday) at 02:30 pm, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended by two Bidders: Zaneya Builders & Supply, and Rosand Builders Corporation;
- WHEREAS,** during the opening of the Eligibility and Technical Envelopes, the above-mentioned bidders "PASSED" the evaluation and was declared eligible for the opening of the financial envelopes;
- WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidder, its bid proposal "As Read" are as follows:

WHEREAS, after reading and determining the amount of bids as proposed by the qualified bidders/suppliers, the BAC declared **Zaney Builders & Supply and Rosand Builders Corporation** offered the single bid as read for the said procurement project and will be subjected to post-bidding evaluation process to be conducted by the TWG;

WHEREAS, in the detailed Bid Evaluation Report submitted by the Technical Working Group (TWG), it was proposed that **Zaney Builders & Supply** be declared as the **Lowest Calculated Bidder** and therefore recommend to proceed in the conduct of Post Qualification procedure;

WHEREAS, the Technical Working Group (TWG) recommended in the Post Qualification Report that the award for procurement project be awarded to **Zaney Builders & Supply** for being the **Lowest Calculated and Responsive Bidder**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the procurement of the project with Bid Reference No. 2023-67 entitled "IMPROVEMENT OF FISHCORE OFFICE AT 2ND FLOOR OF NFA BUILDING", be awarded to **ZANEYA BUILDERS & SUPPLY** in the amount of **TWO MILLION NINE HUNDRED SEVENTY-ONE THOUSAND EIGHTY-SIX PESOS AND FIFTY-SIX CENTAVOS (Php 2,971,086.56)** for being the bidder who offered the **Lowest Calculated and Responsive Bid**;

RESOLVED FINALLY that the Notice of Award be issued to the above-stated bidder for the preparation of the Contract Agreement, Notice to Proceed and commencement of the Service;
